The OECD Economic Outlook database provides historical trends and future projections for a range of economic statistics. These include demand and gross domestic product (GDP), deflators and prices, general government accounts, households and business sectors, labor market, financial data, foreign exchange market, balance of payments, supply block, oil market, and other raw materials.


